- 215 tests were run in the 2017/2018 season

Fundraising Report

- 1. Skate Ontario Promotion through Lottery ticket sales. Club sold 20 books. Most of which were sold during the exhibition day (82 tickets sold on exhibition day).. About \$440.00 dollars profit from the books went to the club and \$360.00 went to Skate Ontario
- 2. Fudge sale: Clubs biggest fundraiser in 2019. Raised \$1432.95 in profit. Sold 395 fudge packages. X-mas was ideal time for the sale of fudge for success.
- 3. Total funds raised for the year \$1872.95. A successful fundraising year.

Technical Co-ordinators Report

• Ten SWSC skaters qualified to Skate Ontario Championships with three skaters medaling. Three

skaters qualified to Skate Canada Challenge and Skate Canada Junior National Championships. Three

adult skaters competed and medaled at the Skate Ontario Adult Championships. One skater was

selected and attended the Children's World Games, one skater was selected and attended the North

American Series, and a third skater was nominated for a WESPY award.

• Several STARSkate sessions operating at full capacity. Talent ID from CanSkate continues to grow STARSkate numbers.

• Organized and ran 4 club test days in cooperation with the test chair. Fewer test days than previous year a direct result of STAR 1-5 full implementation with coach assessments. Future test days

expected to use less ice time, due to full launch of STAR 6-Gold, as of September 1st, 2019 with coaches

to assess more tests. Approximately the same number of test days will be required.

• Organized and ran 2 seminars with Aaron Lowe for all STAR 3-Gold skaters, as per Skate Ontario's direction to hold more Performance Days

• Trial use of PAs during STAR 1-2 Spring sessions proved effective and benefited the skaters, coaches, and PAs.

• Enforcement of Skate Ontario Concussion Policy / Skate Canada Incident Reports. Ongoing communication and reminders to coaches of protocol throughout season.

The following are our recommendations for 2019-2020 Fall/Winter program (***with status quo unless

otherwise noted):

• Authorize the use of one Senior PA on all STAR 1-2 sessions year round (as needed).

• Continue to offer three separate sessions for STARSkate levels, where possible, due to high projected registration numbers. Minimize and/or eliminate the overlap of sessions.

• All coaches must complete STAR 6-Gold update training over the Summer (full launch September 1st, 2019)

• Coaches' intentions for next season will be sent out mid-August. Once reviewed, applications from new/outside coaches to the club should be considered on an as needed basis.

• Implement informal feedback sessions once per season for coaches paid by the club.

• Formalize the procedure for substitute coaching on STARSkate time.
